OFFICIAL PROCEEDINGS OF THE LAMOURE COUNTY COMMISSION MEETING September 1, 2015

At 8:30 a.m. Chairman Keith Heidinger called the meeting to order and opened with the pledge to the flag. Commissioners Victor Weigel, Lee Miller, Bruce Klein and Bob Flath were also present. Attending the meeting were Lauren Worrel, County Highway Department; Marlene White, County Auditor; Tonya Duffy, State's Attorney; Dave Opdahl, Custodian; Tina Thornton, Kulm City Auditor; Jan Meidinger, Tax Director; Mike Rhinehart, Butler Machinery; Tom Silvernagle, Butler Machinery; Gerald Harris, LaMoure Chronicle; Patty Wood Bartle, The Edgeley Mail; and Verleen Shear.

Chmn Heidinger asked for additions to the agenda. Assessor for Tax Department, Jamestown Community Correction Program, Approve Social Services bills, Approve August meeting minutes and the museum were added to the agenda. Motion to accept the additions to the agenda by Comm Klein, seconded by Comm Miller. Motion carried.

Motion to pay Social Services' bills of \$5,503.10 by Comm Weigel, seconded by Comm Klein. Motion carried.

Motion to approve August minutes by Comm Weigel, seconded by Comm Klein. Motion carried.

Lauren Worrel reported that road crews are grading township and county roads and crushing chips in the Seefeldt. Worrel stated that the last lift of gravel on Co Rd 34 would be today, and they will start graveling on Co Rd 64. Worrel said that crews will be hauling chips over to Co Rd 66, and chip sealing will be done in the following weeks; weather permitting. Worrel also said that crews will also be sweeping chips off Co Rd 61 for center line stripes.

Worrel reported that seeding is complete on Co Rd 63 by Adrian with clean up, signing, erosion control and fencing being done. Worrel said there is also repair work being done on two culverts.

Worrel reported that Co Rd 61 has shoulder removal and patching being done later this week, and paving late next week depending on how well the patching and shouldering go.

Worrell submitted another installment payment of \$703,225.93 for the Knife River project CNOB-CNOA-2325(056) which will not be sent until reimbursement is received from the State.

Worrel has a county road study from NDSU which he will complete and have the Commissioners review at another meeting.

There was just one road grader bid to open at 9:00am which was from Butler Machinery presented by Mike Rhinehart, salesman and Tom Silvernagle, Butler Machinery Store Manager in Jamestown, ND. The bid was for a 140 M3 CAT for \$306,125. The County would trade in a 2001 140H CAT with a value of \$72,565, bringing the purchase price down to \$233,560. Motion to purchase the 140 M3 CAT and trade in the 2001 140H at a cost of \$233,560 with a repurchase price of \$145,000 at the end of 7 years or 7500 hours by Comm Miller, seconded by Comm Weigel. Roll call vote taken with unanimous yes votes.

Marlene White, County Auditor, presented the Jamestown Community Correction service contract for renewal. The cost last year was \$1,063.13 per quarter, and next year it will be \$1,095.40 per quarter. Motion to enter in to contract with Jamestown Community Correction Program for 2016 by Comm Flath, seconded by Comm Miller. Motion carried.

The Commissioners received a quote for certified maintenance from Titan Machinery for the courthouse generator of \$685 per year. The Cummins Motor Company maintenance agreement would cost \$2,123 per year. Motion to enter into agreement

with Titan Machinery for maintenance on the courthouse generator by Comm Flath, seconded by Comm Weigel. Motion carried.

Comm Weigel stated that the LaMoure County Museum Board needed to replace board member Pauline Bergman of Jud. Motion to appoint Terri Potts of LaMoure to the LaMoure County Museum Board by Comm Flath, seconded by Comm Miller. Motion carried.

Jan Meidinger, Tax Director, informed the Commissioners that all tax assessors will be required to have 80 hours of assessing classes in order to be a Class II Assessor in the State of North Dakota. The assessors taking the classes would have to pay over \$1200 out of their own pockets for these expenses. Meidinger has checked with the assessors who are left in the county, and none of them wish to get the necessary 80 hours of training at this time. After much discussion, Meidinger requested that the County hire a full-time person for assessing the properties in LaMoure County. Motion to open a position and advertise for a full-time Class II Assessor for the Tax Director's office by Comm Flath, seconded by Comm Klein. Roll call vote taken with unanimous yes result.

Dave Opdahl, Custodian, presented a list of projects that he has completed around the courthouse along with other projects he still needs to work on. Opdahl requested that he be allowed to continue the 45 hour work week in order to complete the unfinished projects. Motion to continue the extra 5 hours per week for the custodian through December 31, 2015 by Comm Weigel, seconded by Comm Flath. Motion carried.

Tina Thornton, Kulm City Auditor, stated that the Emergency Generator has been installed at the Kulm Community Center. Thornton stated that the City of Kulm share of the total was \$8,945.90. Thornton asked the Commissioners to grant \$6,000 to the City of Kulm to help cover the cost of this project. The Commissioners decided to table this until the next meeting on September 15, 2015.

The Commissioners scheduled a budget hearing on September 10, 2015 at 8:30am. Auditor White informed the Commissioners that Tanya Wieler of Dakota Dynamics would be able to meet with them October 14, 2015, so a budget hearing was schedule that day as well at 8:30am.

White presented correspondence to the Commissioners for their review with no action being necessary.
