OFFICIAL PROCEEDINGS OF THE LAMOURE COUNTY BOARD OF COUNTY COMMISSIONERS MEETING-Tuesday, January 21st, 2025

At 8:30 a.m., Chairman Jason Weigel called the meeting to order and opened by reciting the pledge of allegiance. Commissioners: Keith Heidinger, Robert Flath, Bruce Klein and Wayne Wald were present. Also attending were Jan Hamlin, Auditor; Darrick Nitschke, Highway Superintendent; Art Hagebock, LaMoure Chronicle; Tim Leppert; and Joel Leppert. Absent was State's Attorney Fallon Kelly.

Chairman Heidinger called for additions to the agenda. The additions were fire district hearing minutes, Richard Long, and bridge. Comm Klein made a motion to approve the agenda with the addition, seconded by Comm Weigel. All voting aye, motion carried.

Chairman Heidinger called for a review of the January 7th commissioner meeting, December 30th special meeting minutes with addition of bills, and January 14th LaMoure Fire Protection District hearing minutes. Comm Flath made a motion to approve all minutes as present, seconded by Comm Klein. All voting aye, motion carried.

Highway Superintendent, Darrick Nitschke, presented to the board a color-coded map to assist in deciding on projects for 2025. Darrick's map had marked out which road has applied for grants for the hot-in-place, plans to chip seal, and also 11 miles of ground work where they may do reclaiming. A lot of these plans are contingent on grant funds. The final determinations on where road work will take place will be made at a later date.

Comm Wald received complaints of the bridge weight restriction south of Adrian. The recommendation was made to have the weight restricted signs further from the bridge to alert truck drivers sooner, and allow turnaround time.

Richard Long came to the board with concerns of JetX Power lines.
